Let us reassure you that you are not being singled out. For confidentiality reasons, we do no publicly disclose the names or the reasons for anyone being cited for a violation. Chances are that similar violations in the community are already being addressed by the Board. However, if you see a violation of any kind, please bring it to the Board's attention. FYI: REGARDING A NOTICE OF VIOLATION

If you receive a notice indicating you may be in violation, it is the Board's attempt to do their mandated job to enforce the rules and regulations set forth in the governing documents that you all accepted when you purchased your property in Woodcreek.

The Board is obligated to treat all like violations in a similar manner. This prevents misunderstandings and confusion, and allows the Board to perform its job as efficiently as possible. With a little help and understanding from all owners, the community can work together to maintain the value of each individual property and continuity of the community at large.

Our first step is always to send a reminder notice with no fine attached. This provides an owner the opportunity to resolve his/her violation issue and it also allows the Board to correct any error brought to their attention before a monetary penalty is levied.

The Board believes that *mutual courtesy and common sense* are important cornerstones of all policies, processes, and procedures.
